1. CALL TO ORDER

Chancellor King called the Zoom Conference meeting to order at 2:32 p.m.

2. FINALIZE AGENDA & MINUTES OF MEETINGS

The April 20, 2020 meeting agenda and minutes of the April 13, 2020 meeting were approved by consensus.

3. COVID-19 UPDATES

Vice Chancellor Mario Rodriguez discussed the one-time \$27.1 million CARES Act allocation for Los Rios to help address the immediate and urgent impacts on our students and colleges. The current challenge is the short time frame to get feedback and determine the best way to distribute the resources. The initial disbursements of funds will be in early May.

Associate Vice Chancellor Paula Allison reported that fundraising has been extremely successful. We've raised \$110K for our relief fund with more to come. There has been a significant uptick in student relief fund applications, and we're still pursuing the opportunity to partner with Edquity so we can deliver the funds to students much more quickly. If we decide to move forward, implementation would be for June or July.

ARC Student Senate President Aesha Abduljubbar addressed the limitations on Associated Student Body funds. Vice Chancellor Mario Rodriguez offered to look into and follow up with her. General Counsel Sherry also offered to look into the Ed Code provisions.

District Academic Senate President Julie Oliver shared some insights on the statewide faculty perspective of preparing for the fall, noting there is great concern and anxiety about what the world is going to look like in August when we're supposed to be going back for the semester. Her suggestion is to develop A, B and C plans. As it gets closer, we may need to adapt in different ways. Deputy Chancellor Jamey Nye agreed the conversation has evolved, and we don't have the ability to adhere to the six feet apart social distancing in the classrooms if that is the requirement at that time. There was further discussion about whether we're prepared to potentially livestream from classrooms, which Associate Vice Chancellor of IT Tamara Armstrong confirmed is being looked into. Other platforms were suggested by faculty leaders, but Chancellor King said the goal is to find the balance between what works best while being consistent across the colleges. Multiple platforms would add complexity and expense.

4. FUTURE AGENDA ITEMS AND MEETING SCHEDULE

The next Chancellor's Cabinet meeting is scheduled for Monday, April 27.
