1. CALL TO ORDER

Chancellor King called the Zoom Conference meeting to order at 3:00 p.m.

2. FINALIZE AGENDA & MINUTES OF MEETINGS

The March 8, 2021 meeting agenda and minutes of the March 1, 2021 meeting were approved by consensus.

3. REOPENING PLANNING

Deputy Chancellor Nye provided an update on the latest developments in the rapidly evolving planning discussions about the Fall 2021 schedule. Conversations with senate and union leadership are underway to consider the options for adding inventory to our in-person course offerings if conditions allow, with the good news that regional health conditions are improving. Assuming social distancing is no longer a requirement by the Fall term, the potential expansion of in-person course offerings would still be just a handful compared to our usual schedule with the rest remaining online. The student services that would be available on-ground have not yet been determined but will be part of the planning parameters. Our planning will continue to be responsive to what the student demand is, as well as what the health and safety requirements are.

Planning is also underway for how quickly we can get our facilities back open with all the new health and safety requirements to accommodate faculty who may need to access their offices on a more regular basis.

Chancellor King, Deputy Chancellor Nye, Vice Chancellor Rodriguez, and General Counsel Knapp answered various questions from Chancellor's Cabinet members about the particulars of reopening, such as enforcing the mask policy, providing vaccines on campus, and contact tracing.
